Only Business, Tourist and Transit visas are to be issued on GRATIS to the national of Argentina. Similarly, only Tourist Visas are to be issued on GRATIS basis to the nationals of Uruguay.

4. Visa free Countries:-Nationals of Nepal and Bhutan do not require visa to enter India.
